In consideration of participating in the OOTB Polar Duck Dip Camp Benefit, I represent that I understand the nature of the event and that I and/or my minor child am qualified, in good health, and in proper physical condition to participate in this activity. In the case of a minor child's participation, the child's parent or legal guardian must be present at the event before it begins and until the minor child leaves the premises. I acknowledge that if I and/or my minor child believe event conditions are unsafe, I and/or my minor child will immediately discontinue participation in the activities.

I fully understand that the Polar Duck Dip event involves risks of serious bodily injury, including permanent disability, paralysis, and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I and/or my minor child incur as a result of my and/or my child's participation in the activities.

I hereby release, discharge, and covenant not to sue Occohannock on the Bay Camp and Retreat Center, or their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and owners of the premises, Eastern Shore District of the United Methodist Churches (each considered one of the "releases" herein) from all liability, claims, demands, losses, or damages on my account and/or that of my minor child caused or alleged to be caused in whole or part by negligence of the "releases" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk, I or anyone on my and/or my minor child's behalf, makes claim against any of the "releases", I will indemnify, save, and hold harmless each of the "releases" from any loss, liability, damage, or cost which any may incur as the result of each claim.
